Message from the Chairman



In 2023, ARTBA's primary advocacy focus was year-two implementation of the landmark Infrastructure Investment and Jobs Act (IIJA).

This meant working with congressional allies to help secure \$106 billion in federal highway, public transit and airport investment that is being felt in the construction marketplace. It also meant continuing to push for the implementation of IIJA's policy provisions with a goal of ensuring more efficient project delivery, as intended by Congress.

At the same time, ARTBA was looking down the road. We began laying the groundwork for the next multi-year highway and public transit reauthorization bill, due in fall 2026. The association launched an external communications campaign to tell the story of how federal infrastructure dollars are being used to improve mobility, safety, quality of life and economic opportunity in every state and congressional district in America. This effort featured site visits with members of Congress, project tours and briefings for 100 Capitol Hill staff, and production of 60 written stories and short-form videos for social media highlighting select IIJA projects.

Among other notable activities aimed at serving our members' interests, we:

- Provided learning, networking, business development opportunities, and safety training to 3,600 industry professionals.
- Filed 30 sets of comments with federal agencies on proposed regulations.

Special thanks to ARTBA members and state contractor chapter executives for your personal leadership, engagement, and financial support during 2023. You helped make possible the achievements outlined in this annual report.

MARKET PROTECTION

The implementation of the funding and policy provisions in year-two of the Infrastructure Investment and Jobs Act (IIJA) was the top advocacy priority for ARTBA and its members.

For Fiscal Year 2023, Congress approved \$92.7 billion in highway, bridge, and public transit investment, along with \$3.4 billion in supplemental resources for highways and \$8.9 billion in airport construction funding.


Among other ARTBA initiatives to demonstrate the value of federal transportation investment:

Dec. 7: House staff attended a briefing on IIJA's second anniversary to hear how states have initiated more than 61,000 improvement projects since the law's November 2021 enactment.





Oct. 3: More than 50 Senate staff learned more about how the transportation construction industry and state transportation departments relied on innovation, trust, and hard work to quickly address infrastructure disruptions following a July Pennsylvania interstate highway truck crash and 2022 Florida hurricane.



March 28: ARTBA Chair Paula Hammond testified before the House Highways & Transit Subcommittee and outlined the IIJA projects moving forward in every congressional district. She also voiced the industry's concerns about Buy America, inflation and the need to accelerate transportation project delivery.

Regulatory & Legal Advocacy

ARTBA regularly articulated the need to implement IIJA's policy provisions in a timely manner to maximize the law's funding. The association created new opportunities for its members to interact with federal agency officials and filed over 30 sets of comments with the industry's perspectives on a variety of regulatory matters. Members also participated in webinars with senior Biden administration officials to receive guidance on Davis-Bacon rules and other issues.



On two other noteworthy fronts:

May: The U.S. Supreme Court agreed with ARTBA and the National Stone, Sand & Gravel Association that the Environmental Protection Agency (EPA) exceeded its authority in developing new wetlands regulations. The Court ruled favorably in the *Sackett vs. EPA* case, forcing the agency to rewrite its "Waters of the United States" rule. EPA in September revised its rule but did not follow the Court's directive. In response, ARTBA and industry allies filed new challenges in federal courts in Texas and North Dakota, requesting that the agency comply with the Court's decision.

August: The Biden administration's Made in America Office (MIAO), a component of the White House Office of Management and Budget, released long-awaited parameters for implementing Buy America requirements revised by Congress in the IIJA. At the urging of ARTBA, the U.S. Department of Transportation issued a waiver exempting certain de minimis costs and smaller projects. The guidance, however, leaves substantial uncertainty about the new process which ARTBA is continuing to work to address through the regulatory and litigation arenas.



Transportation Makes America Work (TMAW)

Among key TMAW initiatives:

Infrastructure Investment Works Campaign

June: ARTBA launched a multi-media communications campaign aimed at telling the story of how IIJA funds are being used to fix transportation infrastructure and improve quality of life for communities across the country. These "project profiles" were shared with members of Congress, their staff, state DOTs and other relevant stakeholders. By year's end, more than 60 written profiles and short-form videos were produced and distributed.




Highway Dashboard

Transpolnfo.org

There were more than 900 visits by congressional staff to **Transpolnfo.org**, a newly created portal to access information about the scope of a state's transportation network, funding trends, and the economic impacts of infrastructure investment.



National Bridge Conditions Report

August: ARTBA's 9th annual bridge conditions report card received national attention and was picked up by 400 news outlets.



Transportation Investment Advocacy Center™ (TIAC)

TIAC helped state and local advocates to advance their transportation investment campaigns. This included providing model legislative and ballot language. At the ballot box, voters approved 88 percent of 239 initiatives, which will generate an estimated \$6.6 billion in one-time and recurring revenue for projects. Lawmakers in 29 states also approved 37 measures for over \$23 billion combined in new transportation revenue.
